PRIVACY POLICY

SCOPE

- * The application of BC Broiler Hatching Egg's Privacy Policy is subject to the requirements and provisions of *Access to Information Act*, *Personal Information Protection Act (Alberta)* and the *Privacy Act (Canada)*.

BC BROILER HATCHING EGG'S PRIVACY GUIDELINES

Accountability and Security Safeguards

BC Broiler Hatching Egg is responsible for personal information under its control and is committed to keeping it confidential unless agreement is reached for its release. BC Broiler Hatching Egg shall protect personal information by security safeguards appropriate to the sensitivity of the information.

We safeguard your personal information by:

- * keeping records containing personal information in locked filing cabinets;
- * having up to date computer security such as passwords, encryption and firewalls.

Purposes for Collection of Personal Information

BC Broiler Hatching Egg shall identify the purposes for which personal information is collected at or before the time the information is collected.

Obtaining Consent for Collection, Use or Disclosure of Personal Information

The knowledge and consent of an individual is required for the collection, use, or disclosure of personal information.

Limiting Use, Disclosure, and Retention of Personal Information

BC Broiler Hatching Egg shall not use or disclose personal information for purposes other than those for which it was collected, except with the consent of the individual or as required or permitted by law.

Accuracy of Personal Information

Personal information shall be as accurate, complete, and up-to-date as is necessary for the purposes for which it is to be used. We will keep your information as long as is necessary for the purpose it was collected, and any legal requirements we may have. Once your personal information is no longer required, it will be destroyed.

Openness Concerning Policies and Procedures

BC Broiler Hatching Egg shall make readily available to individuals specific information about its policies and procedures relating to the management of personal information.

Challenging Compliance

An individual shall be able to address any concerns regarding with the above principles to the designated person accountable for BC Broiler Hatching Egg's compliance with the BC Broiler Hatching Egg Privacy Policy.
